8	APPOINTMENT OF AN INDEPENDENT EXAMINER																
8.1	BP was appointed as independent examiner (JF/LD), for which thanks were extended.																
9	PRESENTATION OF AWARDS																
9.1	RT relayed walks, walkers and distance statistics. For the 2022-23 year a total of 78 walks had covered 608 miles, with 1,261 walkers covering 9,774 walker miles. The walks ranged from 4 to 13 miles, with the most people on a walk totalling 40. He extended his thanks to everyone, then presented awards as follows. Membership Secretary’s Special Award: Brian Palmer, for going above and beyond the call of duty to help people, deriving no identifiable benefit to himself. RT cited two examples on his own walks when BP had added to his research and subsequently taken it further in his own time. New Walker of the Year: Ryan Fee, who had achieved the magnificent total of 13 walks. New Leader of the Year: Sue Jones (runners-up Bill Jackson, Adrian Baldwick and Howard Lloyd). Leader of the Year: Karen Lewis (runners-up Alan Wilson, Jeremy Pratt, Liz Lister, Rob Turner and Angela Dobie). RT proposed a new category for the following year based on walker feedback, ie a paragraph to be submitted, describing why a walk was particularly appreciated. There was general agreement from the floor.																
11	ANY OTHER BUSINESS																
11.1	CK suggested that weather conditions could be taken more into account on the day, ie if it were very hot the walk could start earlier, if it were a very long walk there could be three breaks instead of two. Furthermore, on recces near the day, if the terrain were particularly saturated, an alternative route could be devised so that walkers had a more pleasant experience.																
11.2	PL gave a vote of thanks to the committee for their work.
